Proposed Bylaws Changes

The Board of Directors of the Illinois Society of Professional Farm Managers and Rural Appraisers have proposed the following amendments to the Society bylaws. These will be discussed and voted upon during the Business Meeting to be held Thursday, February 6, 2025

Article 10 – Officers and Duties

Section 6. Academic Vice President.

The Academic Vice President shall perform such duties and shall have such powers as may from time to time be assigned by the Board of Directors or the President. The Academic Vice President shall serve as a link to the academic community and seek to inform the academic community of the purpose and mission of the Illinois Society of Professional Farm Managers and Rural Appraisers. The Academic Vice President shall be appointed for a term of three years. The position shall be rotated between representatives of the University of Illinois, Southern Illinois University, Western Illinois University, and Illinois State University. The Academic Vice President shall be appointed for a term of three years. Terms may be extended for any additional terms at the expiration of each term at the discretion of the Board of Directors. Consideration for this position shall be given to representatives of the University of Illinois, Southern Illinois University, Western Illinois University, and Illinois State University.

A recent change to the ASFMRA bylaws passed in February 2024, requires the proposed following amendment to the ISP-FMRA bylaws:

Article 10: Officers and Duties

Section 12. Representatives to the ASFMRA Membership Advisory Group

The Chapter's Board of Directors shall annually appoint the Chapter's representatives to the Membership Advisory Group of the Society from the Accredited, Professional, and Academic members. The officers of the chapter shall be given first consideration for the representative positions to the Membership Advisory Group. The representative's term of office shall begin on January 1 following their appointment. Each representative shall serve for **no less than one year or** no more than three years. A vacancy or substitution in this position shall be filled by a named Alternate also appointed by the Chapter's Board of Directors. However, when the Chapter's representative shall be required to resign his/her position as the Chapter representative and the Board of Directors shall select an Alternate as the representative of the Chapter to the Membership Advisory Group of the Society.

LEX Program Opens Doors on Capitol Hill

A t the end of September, I traveled to Washington D.C. with ASFMRA through the Leadership Excellence (LEX) program sponsored by Pioneer. It was a great experience and an opportunity to learn firsthand about the legislative process. Due to the timing of LEX this year, many of our meetings with legislators were focused on farm bill negotiations.

As a group, LEX participants from across the country met with:

- Sen. Stabbenow, Policy Staff Senate Ag Committee Chair (D-MI)
- Sen. Bozeman, Policy Staff Minority Ranking Member Senate Ag Committee (R-AR)
- Rep. G.T. Thompson, Congressman and his Policy Staff – House Ag Committee Chair (R-PA)

We were also given time to schedule some of our own meetings. During this time, I met with:

- Rep. Mary Miller, Illinois 15th District, and her Policy Staff – Member of House Ag Committee (R-IL)
- Sen. Durbin, Policy Staff Member of Senate Ag Committee (D-IL)
- Sen. Duckworth, Policy Staff (D-IL)

It was a unique opportunity to hear the perspectives of several actors involved with the farm bill.

The one thing they all agreed on -- nothing was going to happen on the farm bill until after the election, and they were all correct about that. We still do not have a farm bill. Looking ahead, some of the most influential crafters of an eventual farm bill were seeing a chance to pass a farm bill during the current lame duck session.

The House passed their version of the farm bill out of committee last May. Illinois was has a lot of representation on that committee, on both sides of the aisle. A bipartisan group of our Illinois Ag committee members voted yes, with the majority, to advance the bill out of committee. Mike Bost (R) IL-12, Mary Miller (R) IL-15, and Eric Sorensen (D) IL-17 all voted yes to advance the bill. Nikki Budzinski (D) IL-13 and Jonathan Jackson (D) IL-01, also from Illinois and on the House Ag Committee, voted no. The ASFMRA policy position on the topic of the farm bill is that one way or another, some form of a farm bill should be passed.

The Senate Ag Committee is farther behind the House in their process, and has not held any committee votes, nor have they released any text of a possible bill. I had the opportunity to question Senate Ag Committee Staff about why their committee was not producing bill text. They responded that they felt the framework that they have produced is adequate at this time. Through LEX, I was able to let them know that I disagreed, and that the senate's framework leaves significant questions unanswered. To their credit, they did also ask our group some questions. They asked whether we see farm program payments being passed along to landowners in the form of higher cash rents. I took this question and responded with a firm, no. I further explained that cash rental rates are too competitive to be affected by safety net levels, and that farmers are not bidding for farms at an expected outcome that would trigger an ARC or PLC payment.

I believe this question comes from direct payment programs of the past, which one could argue, did get internalized into cash rents. Safety nets like ARC and PLC are completely different because they only pay on worse-than-expected outcomes. While I wish that this wasn't a question at this point, I am glad that they asked our group, and I hope the ASFMRA member experience that we shared had some impact. I'm grateful for their willingness to speak with us.

Next, we had a group meeting with Senator Bozeman's policy staff. Senator Bozeman is the minority party ranking member *Continued on Page 8*



Greetings from Illinois College Agribusiness Management (ABM) program located in Jacksonville, Illinois. I am Professor Jeff Galle, coordinator of the ABM program. We are a small private college chartered in 1829, nearing its 200th anniversary. The student body is typically 1,000 students. The ABM program operates under the Business Department, providing students with a core of business classes along with a core of agriculture coursework.

The ABM program at Illinois College has three full-time professors delivering the curriculum and mentoring students. In addition to me, Assistant Professor Tim Finlay joined the faculty and brings a world of Agribusiness experience to the program having worked in the Agribusiness field and corporate America. The newest member of the ABM team is Assistant Professor Dr. Yanan Liu, who recently completed her doctorate at The Ohio State Univer sity. Dr. Liu is developing new courses and will initiate he research program with a diverse focus on Agribusiness.

New courses, including Commodities, Futures and Options plus Charting are being added to the curriculum. Invitin guest speakers into the classroom provides real-world ex posure from a wide variety of professionals.



The ABM program continues to grow and expand with about 50 percent of students attending on campus and 50 percent enrolled in the on-line ABM program. Online courses run eight weeks and are completed asynchronously with students doing their work and submitting assignments on their own time. Every student completes an internship which provides students with a wide variety of real-world experiences. Students benefit from field trips by seeing the diversity of agriculture. "The IC Aggies" organization provides continued leadership opportunities along with fun and professional activities.

The program is growing and expanding with a major effort to inform the ag community of the Agribusiness Management Program at Illinois College.

of the Senate Ag Committee. His staff was eager to get a farm bill passed during the lame duck session between the election and the end of the year. They spoke favorably of the House Farm Bill and expressed some concern about how certain portions of the senate framework would function in practice.

That same day, Congresswoman Mary Miller took a meeting with me in her office on Capitol Hill. I thanked her for her farm bill vote to move the House Bill out of committee. I also took the opportunity to share another ASFMRA policy position with her, the importance of preserving the 1031 tax deferred exchanges. It was good to be able to inform her of this lurking potential concern, and she understood and agreed with ASFMRA's position once she heard more about this niche issue of ours.

The next day, I had separate meetings with policy staff of Senator Dick Durbin and policy staff of Senator Tammy Duckworth in their offices. Being on the Senate Ag Committee, Senator Durbin's staff was already well informed of farm bill issues and indicated an openness to get something passed before year end if the opportunity is presented. Senator Duckworth's policy staff was unsure that a farm bill would get a vote before year end, however, indicated openness to a bill that included Senator Duckworth's non-negotiables. I invited Lauren Roth, of Pioneer to the meetings with Senator Durbin and Duckworth, where we were both their constituents. At senator Duckworth's meeting, Lauren offered a "thank you" to the senator for leadership on sustainable aviation fuel and support for using domestic corn and soybeans. I certainly appreciated Lauren's input here, because I was previously unaware of the extent of Senator Duckworth's involvement and interest in sustainable aviation fuels, and they have the potential to be an important new driver for demand of corn and soybeans.

On our final day, we met as a group with House Ag Committee Chairman G.T. Thompson and his staff. This meeting was extremely impressive as they know their bill backwards and forwards, and they are proud of what they have gotten through committee. There is so much that I could highlight from this meeting. Congressman Thompson expressed gratefulness to all the other members who passed the bill out of committee in the House, and specifically mentioned that Illinois Congressman Eric Sorensen as someone from the opposite party who has worked hard on the bill and taken a tough vote to show bipartisan support for the House Farm Bill.

Another particularly interesting point that Congressman Thompson mentioned was the potential to attach the House's farm bill to other must-pass legislation, such as a continuing resolution to fund the federal government at the end of the year. This is not how farm bills usually

pass, but it was encouraging to see that some are trying to get very creative to get a farm bill across the finish line after such a long delay.

There was so much more that we did at LEX, including some fun between our meetings, but this is already quite long. I've tried to stick to the top highlights. If you are thinking about signing up for the next round of LEX. I encourage you to do it. Talk to me at any ISPFMRA event, and I would be happy to share more!

I also want to give special thanks you to ASFMRA for putting the event together, and to Pioneer for sponsoring LEX! An extra big "thank you" to ASFMRA's Government Relations Representative, Stephen Frerichs. While it was our individual responsibility to coordinate our personal meetings, Stephen made the large group meetings happen and put in a lot of work into coordinating these group meetings with very high-level policy staff, the people who write farm bills, and even the Chairman of the House Ag Committee himself, on Capital Hill. I don't know where else you could have a similar experience to this other than ASFMRA's LEX, sponsored by Pioneer.


